

CALL FOR ABSTRACTS

The Italian Academy of Conservative and Restorative Dentistry (AIC), in collaboration with the European Federation of Conservative Dentistry (EFCD), **is** pleased to announce that the ConsEuro 2026 Meeting will be held in Bologna, Italy, 7–9 May. This event will bring together clinicians, scientists, and researchers from across Europe to present, discuss, and critically evaluate their work in the field of dental research. We warmly invite all researchers engaged in dental science to submit an abstract for consideration for poster or oral presentation.

Presentation Categories

Abstracts may be submitted in the following categories:

- Cariology
- Operative Dentistry
- Clinical Trials
- Dental Materials
- Clinical Cases

Authors may indicate their preferred presentation type (poster or oral). Final allocation will be made by the Scientific Committee.

Awards

Student Oral Presentation Award: 7 May PM presentation session with Q&A; the most prestigious award of the meeting will be assigned to the best oral presentation by a student (undergraduate, postgraduate, or PhD). They will receive 300 euros and a certificate.

Awards will also be assigned to the best poster and the best oral communication in each of the following scientific categories:

- Cariology Award
- Operative Dentistry Award
- Clinical Trials Award
- Dental Materials Award
- Clinical Cases Award

A panel of international experts will evaluate poster presentations with presenter Q&A during the breaks on 7 & 8 May to determine the award recipients. Each first-place poster presentation winner will receive a €200 prize, and runners-up will be rewarded in kind, all with appropriate certificates. A special award will be dedicated to Injection Techniques Cases.



Abstract Submission Guidelines

- Each individual may present only one abstract as the main author; co-authorship on multiple abstracts is permitted.
- Abstracts must describe original research that has not been published or previously presented.

Each abstract must include:

- Title: concise, maximum 12 words
- Authors: list all authors, with the presenting author first; include first name, last name, and affiliation for each
- Category: Cariology, Operative Dentistry, Clinical Trials, Dental Materials, or Clinical Cases
- Preferred presentation type: poster or oral
- Abstract text: maximum 300 words (excluding title, authors, affiliations)

The abstract text must follow this structure:

Objectives – Materials and Methods – Results – Conclusions

References should not be included. One simple table may be inserted if necessary.

Important Dates

- Abstract submission deadline: February 13th, 2026
- Acceptance communication deadline: March 6th, 2026
- Presenter pre-registration deadline: March 27th, 2026

Abstracts will be reviewed as submitted; no modifications will be accepted after the deadline.

Conditions of Submission

By submitting an abstract, authors confirm that:

- 1. All research involving human or animal subjects complies with the principles of the Declaration of Helsinki (World Medical Association).
- 2. The submitted work has not been published or presented elsewhere.
- 3. EFCD is granted permission to publish accepted abstracts in print and/or electronic formats.
- 4. The presenting author will register for the meeting and pay the required fee by February 28th, 2026. Failure to register will result in withdrawal of the abstract from the meeting and from further publication.
- 5. All award winners and runners-up agree to provide a written or video summary of the value of entering the EFCD awards and how the award is important to their careers/professional development, for use on social media and official EFCD websites.
